

Patient-Driven Groupings Model (PDGM)

What you need to know



What is PDGM?

As one of the most significant updates to PPS since 2000, the CMS approach to the Patient-Driven Groupings Model (PDGM) focuses on providing a higher quality of care, keeping individuals in the best acuity setting possible and reducing unnecessary treatment and services. A successor of the proposed Home Health Groupings Model (HHGM), PDGM introduces new payment episode timings and removes therapy visits to determine payment for episodes beginning on or after Jan. 1, 2020.

What does PDGM mean for your organization?

PDGM implements a budget-neutral payment approach, shifting payment for home health organizations, reimbursing more for clinically complex patients and less for therapy-intensive patients. The adjustment better aligns payments with patient needs, ensuring that clinically complex and ill beneficiaries have adequate access to home health.

Under PDGM, a 30-day period is grouped into one subcategory in each of the following areas:

- Admission source and timing from claims
- Clinical grouping from the principal diagnosis reported on the claim
- Functional level of eight OASIS items
- Comorbidity adjustment based on claims

What should your organization consider to prepare?

Organizations that prepare before the Jan. 1, 2020 target date will find themselves to be better positioned to transition to PDGM. To determine if your organization and its operations are ready for payment changes, take the following into consideration:

- Create an internal committee with representatives of all affected departments that are responsible for developing an overall plan for your organization.
- Establish a baseline by running claims through a grouper and compare your current reimbursement to the new PDGM to determine how it will impact your organization financially.

- Make sure that episodes are connected to a clinical grouping to avoid any returned claims from CMS.
- Examine your frontloading practices in care delivery management. Consider developing care transition programs.
- Ensure your EHR has the capabilities to track and report visit frequencies by clinical groups and subgroups.
- Determine the strength of your coding process and resources, following ICD-10.
- Conduct targeted OASIS education so that your clinicians understand the cause and effect.

Once you have determined your organizational needs, document them and share with your EHR partner. Remember to keep a pulse on their updates to help accommodate your PDGM needs.

Impact on home health care operations

Cost reporting: Accurate cost reporting preparation will be extremely important for reimbursement.

Managing care: Oversight and management of the delivery of rehab services are required to provide the right level of service and care based on the patient needs.

Reimbursement: Rehab reimbursement will shift to nursing reimbursement for the quality of care provided.

Staffing: Organizations must ensure they have the appropriate qualified staff to support the changes in patient care and the increased frequency of billing.

Information technology and services: Additional solutions may be especially appealing, such as telemonitoring, document management, additional interfaces to eliminate workarounds and resource management services to augment your billing staff.

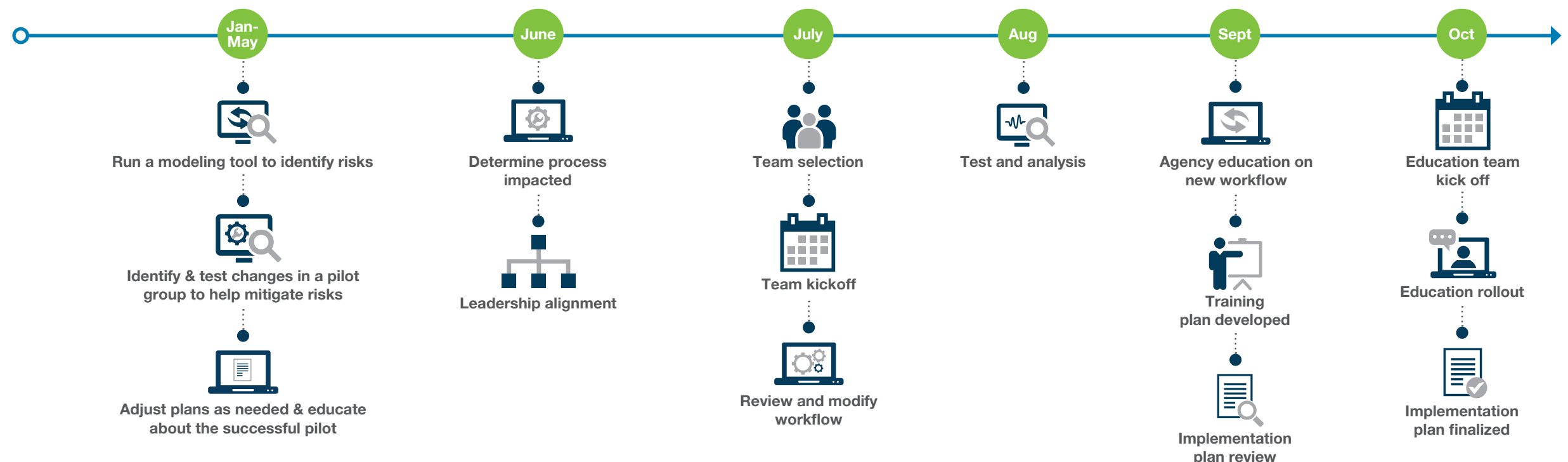
